3. Pre-bid meeting shall be held at **Meeting Hall of National Centre for AIDS& STD Control ,Teku Kathmandu at 13:00 Hr 11 Feburay, 2024.**
4. Electronic bids must be submitted to the office through PPMO's e-GP system [https:// www.bolpatra.gov.np/egp](https://www.bolpatra.gov.np/egp) on or before 23:59 Hr on 6 March 2024 . Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hr 7 March 2024 at the office of **National Centre for AIDS& STD Control Meeting Hall**. Bids must be valid for a period of 120 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, which shall be valid for 30 days beyond the validity period of the bid (i.e., **4 July 2024**)
6. If the bid opening date is declared a government holiday, then the next working day at the same time bid shall be opened.
7. In case of any discrepancies or error in bid document, bid notice or any other document, the National Centre for AIDS & STD Control reserves the right to amend and correct the bid at any time.
8. National Centre for AIDS & STD Control reserves the right to cancel the bidding process partially or wholly without disclosing the reason to the bidders at any time.
9. Bidders may submit the bid for single or more slices and offer discounts/cross discounts. **Evaluation will be done slice by slice basis.**
