4. Pre-bid meeting shall be held at Meeting Hall of National Center for AIDS and STD Control, Teku, Kathmandu at 20th September 2024, at 13:00 PM.  
5. Electronic bids must be submitted to the office of NCASC, Teku Kathmandu by through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 23:59 Hr on 18th October 2024. Bids received after this deadline will be rejected.  
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hr 20th October 2024 at the office of National Center for AIDS and STD Control, Teku, Kathmandu Hall. Bids must be valid for a period of 120 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 37,83,000.00 (Thirty seven lakh eighty three thousand only) which shall be valid for 30 days beyond the validity period of the bid (i.e. ., 19th March 2025)  
7. Evaluation will be done on package basis.  
8. In case of any discrepancies or error in bid document, bid notice or any other document, the National Centre for AIDS & STD Control reserves the right to amend and correct the bid at any time.  
9. National Centre for AIDS & STD Control reserves the right to cancel the bidding process partially or wholly without disclosing the reason to the bidders at any time.
